Lasar and I went to the CDSP trial in Champaign on February 9 & 10, 2013. He now has 9 of the needed 10 legs toward his Novice Championship after getting 4 legs there. Just need 1 more. We also showed in Open A. He got his Open title on Sunday morning so the next trial we moved to Open C and earned his 1st leg toward the Open Championship. All in all, it was a very good weekend. Between Novice C four times and Open also four times, we had eight trips in the ring. Lasar survived two runoffs, winning both of them. We were 8 for 8 in the ring earning 8 first places, a new CDX title and two High in Trials.

On March 16th at the UKC obedience trial in Lowell, In., Lasar was entered in Open A for the first time. He picked up 2 legs toward his Open title with 2 first places. He also finished first twice in Novice C earning All Star points in Open and Novice.

The next weekend was the APDT rally trial which is held at my club every March. He still needed to show in Level 1 because he needed 3 more QQ's in Levels 1 & 2 toward the ARCHX title. This title requires 5 QQ's in both Level 1 & 2 with scores of 195 or above. He is also working on his Level 3 Championship. So, Lasar was all the classes in all 4 trials, which put him in the ring 12 times over the 2 day trial and all were perfect scores of 210. This was only the second time ever that a dog had gotten all perfect scores. He also earned 3 new titles, ARCHX, Level 1 Championship and Level 2 Championship.



Two weeks later, we were entered in the Lafayette, In. AKC trial. This was again the first time for AKC Open. He NQ'd the first time due to handler error. But, came back on Sunday to get a first leg and a 1st place with a 197 and a very nice complement from the judge. She said to me after placements that "I very seldom

see perfect heeling in the ring. But your dog had perfect heeling" Made me feel very good. It's nice when the judge says something nice about your dog.

Then on May 3-5 in Peoria, Il. UKC trial, Laser earned his last leg to finish his Open title with 2 extra legs which will go toward All Star points. And, another 4 qualifying scores in Novice C.

## AKC Board Approved Change to Rally Events

### To all AKC Clubs Licensed for Obedience/Rally/Tracking:

I would like to take the opportunity to highlight a couple of changes approved by the AKC Board of Directors that may benefit your club.

### **AKC RALLY® REGULATION CHANGES: Effective June 1, 2013 — Rally Trials are now a separate event**

Clubs may now hold Rally Trials without regard to the number of Obedience Trials they are also holding. Rally is now considered a separate AKC event and is not tied to any other AKC event. If a club is licensed for Obedience they may now hold up to 12 Rally Trials per year. Any clubs not currently licensed for Obedience but who would like to offer Rally events will be required to successfully hold a minimum of one Sanctioned Rally A Match. For more information please contact the Companion Events Department at [Rally@akc.org](mailto:Rally@akc.org). The Regulations for Rally have been changed as shown below.

### **Chapter 1, Section 1. Application to Hold a Rally Trial.**

Clubs meeting the AKC requirements that wish to hold a rally trial must apply on the form provided by the AKC and submit the appropriate application fee. A rally trial is a separate event with a separate event number. The event application and fee must be submitted at least 18 weeks before the closing date for entries to the event. The trial may be held as a separate event or in conjunction with another event. Clubs may hold no more than 12 Rally trials per calendar year.

### **Effective Immediately — AKC Rally® National Championship.**

The AKC Board approved an AKC Rally® National Championship, and amended the Rally Regulations to provide for it. The first event will be held in the spring of 2014 in conjunction with the Companion Events Extravaganza.

### **EVENT APPLICATION FEES: Effective January 1, 2014 — New Event Application Fees.**

The AKC Rally®, Obedience, Tracking and Agility event application fees have been changed effective for events held on or after **January 1, 2014** as follows:

AKC Rally trials with over 30 entries (based on the previous year's corresponding trial) will have a \$50.00 event application fee (a reduction from the current \$100.00 application fee).

Regardless of the number of entries based on the previous year's corresponding trial, a minimum event application fee of \$25.00 will be charged for:

- Rally Trials
- Stand-alone Obedience Trials
- Tracking Tests
- Agility Trials

# THE SPAY/NEUTER DEBATE

As I start writing this article for the American Airedale my first thought is there is not enough time to read all the research associated with this topic and many people already have their own strong opinions on this topic. This slight overview only highlights some already formed opinions and some research data. I do wish to acknowledge Susan Anderson and Susan Kuhn for providing research articles for the basis of this report.

For me, I grew up on a farm with variety of animals with dogs and horses being my love. I remember our vet who was an "old time" horse vet in the area, but whom also practiced on small animals. His recommendation was that you should never geld a stud until at least two years of age. His reasoning: They never developed physically. In applying this reasoning to dogs, that vet 50 years ago was probably onto something. With today's world and the research that is being done on a variety of health fronts, all we can do is arm ourselves with knowledge and make the best possible choices for canines. The following is a brief synopsis of the pros and cons of spay/neuter debate.

Chris Zink, DVM, PhD, DACVP, DACVSMR tackles several aspects of the early spay/neuter debate. In short Dr. Zink believes that owners and veterinarians might wish to reevaluate the practice of spaying/neutering at or before the six month age mark. In the orthopedic area, some research indicates dogs spayed or neutered at or before puberty often have longer limbs, lighter bone structure and just an underdevelopment of their structure. Dr. Zink also mentions that bitches spayed at 7 weeks had a delayed closure of their growth plates compared to those spayed at 7 months and those spayed at 7 months had a delayed closure of growth plates as compared to those dogs that were left intact. It was also noted that certain bones; i.e. the tibia and radius and ulna were longer than the femur and humerus in dogs that were spayed or neutered at or before 8 months as compared to those left intact. We all know that keeping a dogs weight in the normal range will certainly help in mitigating some ortho conditions. I can hear that "old time" horse vet now!!

With regard to cancer studies, Dr. Zink reported in short that the risk factors for certain cancers i.e. cardiac hemangiosarcoma, bone cancer, prostate problems in males, and bladder tumors were elevated due to an early spay or neuter.

On the mammary cancer front, Dr. Zink reported that there was a slight increase in mammary cancer in female dogs after one heat cycle and a greater risk after each subsequent heat cycle. The thing that I found most interesting is his recommendation that veterinarians should be developing x-ray imaging for early diagnosis of mammary cancer. That technology will hopefully be right around the corner, but of course some of this equipment might only be available at large teaching hospitals.

In reading Dr. Zink's report I found it very interesting to read about other health concerns that might be prevalent in the spayed and/or neutered dog. Females and sometimes males that were fixed before puberty had an increased risk of urinary incontinence. Most noted was the adverse reactions to vaccines, which was 27 to 38% greater in neutered dogs as compared to intact dogs. Spayed dogs displayed a higher risk for hypothyroidism as compared to intact dogs.

As is the practice of ongoing clinical studies in humans, Dr. Zink also feels more studies are needed to decide on future health risks and benefits associated with spaying and neutering. At this time however Dr. Zink does have concerns with the spaying and neutering of males and females. In other words all that equipment is necessary for development, reproduction and the long-term health of our pets.

The Long-Term Health Effects of Spay/Neuter in Dogs  
By: Laura J. Sanborn, March 2007

The above author has offered a summary on her paper and in an effort to para-phrase she offers following insights:

She writes there seems to be no compelling case for neutering most male dogs, especially the immature one, in order to prevent future health problems. Neutering may only bring forth some health problems and these may exceed the associated health benefits.

If one does decide to neuter the male dog some of the benefits are:

1. Eliminates the small risk of dying from testicular cancer.
2. Reduces the risk of non-cancerous prostate disorders
3. Reduces the risk of perianal fistulas
4. May reduce diabetes (data inconclusive)

The negative aspects to neutering are many. They include:

1. If neutering is done before maturity, it increases the risk of bone cancer. This type of cancer is common in medium/large and larger breeds.
2. Increased risk for cardiac hemangiosarcoma
3. It triples the risk of hypothyroidism
4. Increases the risk of cognitive impairment,
5. Obesity is prevalent,
6. Quadruples the small risk of prostate cancer
7. Doubles the small risk of urinary tract cancers
8. Increases orthopedic disorders and then there is adverse reactions to vaccinations.

With regard to female dogs, Laura notes that the health benefits that are associated with spaying may exceed the health problems in some cases. She further notes that the overall health of the female depends on the age and the relative risk of various diseases in the different breeds. Some of the positives associated with spaying are:

1. If done before 2.5 years of age, it does reduce the risk of mammary tumors,
2. Nearly eliminates pyometra
3. Removes the risk of uterine, cervical and ovarian tumors and
4. Reduces perianal fistulas.

The negative aspects of spaying include

1. If done before maturity, increases the risk of osteosarcoma, by a factor of 3.1
2. Increases the risk of splenic hemangiosarcoma and cardiac hemangiosarcoma.
3. Triples the risk of hypothyroidism

4. Increases obesity
5. Increases the risk of recessed vulva, vaginal dermatitis if spayed before puberty.
6. Increases the risk of urinary tract tumors,
7. Orthopedic disorders and increases the risk of adverse reactions to vaccinations.

Laura Sanborn writes that the information available to the public is not great, often unsupported and exaggerated. I know personally and I am sure you do as well, that many vets lecture new puppy owners on the hazards of health if they do not get their dog spayed or neutered ASAP. In other words it's an educational process that we are going to have to work on with new puppy people. Laura Sanborn writes that the traditional spay/neuter age of six months along with the practice of pediatric spay/neuter, appears to put dogs at risk that otherwise could have been possibly avoided until a later date.

The Airedale Terrier Club of Illinois just hosted a vaccination seminar with Dr. Ronald Schultz of the U.W. Veterinarian Clinic, Madison, Wisconsin this past weekend. While I am not going to get into the data on this seminar, it is noteworthy to express that educating the public with protocols on spay/neuter or vaccinations is challenging. One of the biggest problems we have is trying to get legislative bodies on hand to change their thought process. This would be the challenging part as changes are expensive to implement and in the end it would affect pocket books. We all have our work cut out for us.

#### Abstract

In contrast to European countries, the overwhelming majority of dogs in the U.S. are neutered (including spaying), usually done before one year

of age. Given the importance of gonad hormones in growth and development, this cultural contrast invites an analysis of the multiple organ systems that may be adversely affected by neutering. Using a single breed-specific dataset, the objective was to examine the variables of gender and age at the time of neutering versus leaving dogs gonadally intact, on all diseases occurring with sufficient frequency for statistical analyses. Given its popularity and vulnerability to various cancers and joint disorders, the Golden Retriever was chosen for this study. Veterinary hospital records of 759 client-owned, intact and neutered female and male dogs, 1–8 years old, were examined for diagnoses of hip dysplasia (HD), cranial cruciate ligament tear (CCL), lymphosarcoma (LSA), hemangiosarcoma (HSA), and mast cell tumor (MCT). Patients were classified as intact, or neutered early (<12 mo) or late (≥12 mo). Statistical analyses involved survival analyses and incidence rate comparisons. Outcomes at the 5 percent level of significance are reported. Of early-neutered males, 10 percent were diagnosed with HD, double the occurrence in intact males. There were no cases of CCL diagnosed in intact males or females, but in early-neutered males and females the occurrences were 5 percent and 8 percent, respectively. Almost 10 percent of early-neutered males were diagnosed with LSA, 3 times more than intact males. The percentage of HSA cases in late-neutered females (about 8 percent) was 4 times more than intact and early-neutered females. There were no cases of MCT in intact females, but the occurrence was nearly 6 percent in late-neutered females. The results have health implications for Golden Retriever companion and service dogs, and for oncologists using dogs as models of cancers that occur in humans.

Cognitive function may be altered by gonadectomy. Comparison of the progression of cognitive dysfunction in sexually intact and castrated male dogs revealed a slowing of progression in sexually intact males.<sup>48</sup> Sample size was small in that study, with only 6 dogs in the sexually intact male group. Androgen deprivation has been associated with increased amyloid deposition in brains of humans and rodents and with decreased synapses in brains of rodents and nonhuman primates.<sup>49</sup> However, in a study<sup>50</sup> in which investigators directly examined brain tissue for DNA damage, a significantly greater percentage of neurons had extensive DNA damage in sexually intact Beagles than in castrated Beagles
